### 3B. Project Description

**1. Provide a description that addresses the entire scope of the proposed project.**

ACTS operates fixed site supportive housing programs in Polk County, Lakeland Florida for persons with children who are homeless with disabilities or fleeing domestic violence situation. This request is for ACTS to continue to provide housing and case management to families with children that are homeless with at least one adult with a disabling condition. Our request is for renewal funding in the amount of \$55,379 for 8 units and up to 16 beds. The purpose of this program is to provide long-term community-based low barrier permanent housing and supportive services to persons with children who are homeless and have a disabling mental health or substance use disorder. Two units will be designated for chronic homeless. Combined characteristics of persons who are mentally ill and/or substance abusing indicate the need for supportive services move out of homelessness and maintain stable housing. Few permanent housing opportunities are available to assist families with long term stabilization. ACTS will provide housing and strong community support via case management, assistance with transportation, and linkage to ancillary services, such as education, positive parenting employment training, employment, transportation, money skills training, credit management, recovery support , mental health/ substance use treatment and other support groups. Residents of ACTS Moonlite PHP will work with a case manager that will have contact with them a minimum of bi-monthly or more as needed. The case manager will complete a comprehensive assessment and individualized treatment plan to promote stable housing, increased income and self sufficiency. Program participants are not required to receive services or treatment as a condition of keeping their housing. This program follows the housing first and low barrier philosophy and Prioritize placements within the Coordinated Intake System . Individuals and families need a safe affordable place to live in order to really address conditions that may have led to their homelessness.
