3B. Project Description

ACTS operates a scattered site leasing permanent housing programs located in Polk County, Florida for persons who are chronically homeless and homeless with a disabling condition.

ACTS' is requesting to renew Polk Winterhaven Scattered Site Leasing Permanent Housing Program to continue to provide 14 units for single persons who are homeless with disabilities or persons that meet the criteria for chronically homeless(may serve families meeting the same criteria with children) Project participants will pay no more than 30% of their adjusted income towards their rent.

Household income must be equal to or less than 50% of the area median income and at least one adult member of the household must have a disability which impairs their functioning level including one or more of the following, diagnosable substance use disorder, serious mental illness, developmental disability, or chronic physical illness limiting their ability to work or perform one or more activities of daily living.

Socioeconomic characteristics of this population : have less than a high school education, are unemployed, have little or no income except some form of public assistance, are presently or have been involved with the criminal justice system or the protective services system, have been admitted to treatment at least one time in the past. Individual conditions are complicated and complex; providing direct access to housing of choice and supportive services individuals are able to achieve success in maintaining stable housing.

ACTS will provide case management that will include but not limited too comprehensive assessment, individualized treatment planning and assistance with achieving identified goals. The case manager will work with the individual or family to achieve long term housing stability, increased financial stability, increased health and wellness and vocational/ educational or meaningful activity. The case manager will see the residents a minimum of bi-monthly or more as needed and will provide assistance in areas that will help them make progress in achieving their individual goals. Such activities as education, employment training, transportation assistance, budgeting, recovery support and access to mental health and substance use treatment. Program participants are not required to receive services or treatment as a condition of keeping their housing. The program operates from a low barrier housing first and Role Recovery Model, and receives referrals from the CoC Coordinated Entry Priority System. Program goals are to promote housing stability, self sufficiency through increased income and increased social connectedness.
