The Homeless Management Information System (HMIS) for the FL-503 Lakeland/Winter Haven/Polk County Continuum of Care is a county-wide implementation, with the Homeless Coalition of Polk County (HCPC) as the designated HMIS Lead Agency. The HMIS system is used to provide data for federal, state, and local funders as well as for program performance evaluation and analysis. HCPC continues to stress the value of complete and accurate data as part of an overall strategy to enhance collaboration, facilitate project and unmet need analysis, and improve reporting quality.

HCPC provides HMIS support and training to approximately 76 end users from 16 different organizations, including emergency shelters, transitional housing, permanent supportive housing, and rapid rehousing. Programs include those funded by CoC funding, ESG, VA, others funded by local government and private funders. HCPC's HMIS staff also manages global system issues including security and privacy, data sharing, user training, data quality monitoring and cleansing, and other HMIS requirements and responsibilities. All data used for Annual Performance Reports, Annual Homelessness Assessment Reports, Sheltered Point in Time Counts, Housing Inventory Counts, Performance Measurement reports, and many other reports, is drawn solely from HMIS.
