The goal the Rapid Rehousing For Polk County program is to provide both financial and support services necessary for people to maintain permanent housing. Using the Housing First model, we focus on crisis resolution, client choice, respect and empowerment, providing the minimum assistance necessary for the shortest time possible, and maximizing community resources. Community Need and Reason for CoC support. There is an identified need for programs to permanently house homeless families and individuals. Families and individuals are staying on our Coordinated Entry list for an unacceptably long time because of the lack of funding for our rapid rehousing programs. The CoC has made this a priority and has increased funding from other sources. We have been successful in increasing funding, but it is not enough.

Project Plan. Families will be initially assessed at one of the coordinated entry centers in Polk County. The entry center will determine whether a family is homeless, administer the Vulnerability Index & Service Prioritization Decision Assistance Tool (VI-SPDAT) to determine preliminary needs and priority, collect basic demographic information, and refer the family to the appropriate housing program including this program. For Talbot House referrals, a case manager is assigned to the family who working with the family and the housing specialist develops a Housing Stability Plan tailored to the family's needs using the Progressive Engagement Model. The case manager locates housing and provides supportive services.

Program Outcome. The outcome for this project is that clients who enter the program leave with affordable permanent housing and the support to stay housed. Since the population served by this program is low- and no-income families who are homeless placement in affordable permanent housing will be a significant accomplishment which will have great benefits for the Polk county community and the client.

Target Population. The rapid re-housing project will serve low and no-income families in Polk County, Florida. The activities of this program include counseling clients to determine their housing needs, assisting in locating suitable housing, and if needed providing rental assistance along with security and utility deposits.

Coordination & Partners. We are active in the Homeless Coalition of Polk County and cooperate with other homeless services providers. We provide mental, physical, and dental health care to our clients, as well as to clients of The Salvation Army, The Lighthouse, Women's Care Center, and the House of Israel. We work with Polk Career Source to help our clients obtain employment and/or benefits. We work with most of the churches in Polk County and the

Department of Children and Families. Agencies such as Peace River Center and Tri-County Human Services provide specialized mental health care, substance abuse interventions, and domestic violence services to our clients.
